

Economic Development Board Meeting Minutes, August 16, 2023

The Board revisited the previously approved Kassidy Urling Down Payment Assistance application. A motion was made by Darcy Johnson, seconded by Jan tenBensel, to ratify to the lower amount requested. Motion carried.
