# City of Cambridge City Council Meeting Monday, March 1 2021 6:30 P.M. Cambridge Community Building 722 Patterson St

Pursuant to notice published in the Valley Voice on Thursday, February 25, 2021, the Cambridge City Council convened in open public meeting at 6:30 P.M. on March 1, 2021 at the Cambridge Community Building. Present were Mayor David Gunderson, City Council Members Vernita Saylor, Tony Groshong, Jeff Ommert, Mike Harris, Derek Raburn, and Kevin Banzhaf. ### Public Hearing – Add Day Care Center to "C-1" and "C-2" Zoning:

City Clerk/Treasurer Kandra Kinne and Director of Economic Development Melissa Jackson attended the February 17, 2021 meeting of the Citizen Advisory Committee meeting where the report was approved. There was no further comment.

## Reports of Officers, Boards and Committees:

- a. Utility Supervisor Report Dave Houghtelling reported on the following projects: Air Permit Emissions with Olsson at a cost estimate of \$15,000; pre-construction meeting for the swimming pool project held on February 25 with work to start on August 8; bridge inspection was performed on the bridge to the Park; generation during the frigid weather; snow removal; three water leaks; Figgins Construction's quote for armor coating 17 18 City blocks at \$89,266.65 plus \$4,000 to \$5,000 for gravel. Derek Raburn stated the motion, seconded by Tony Groshong, to approve retaining Figgins Construction for armor coating 17 18 blocks at a quote of \$89,266.65 plus \$4,000 to \$5,000 for gravel. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Mike Harris, Derek Raburn and Kevin Banzhaf, none voted no. Motion carried unanimously to accept the quote of Figgins Construction for armor coating.
- b. City Clerk/Treasurer Report Kandra Kinne reported on the following projects: advertising for water/wastewater position; problem with lock on double doors in large room submitted to Axxent; Flood Plain Mitigation Plan submitted; Steve Johnson reported that Northwestern Mutual Employee Benefits Agency was acquired by Patriot Growth Insurance Services; audit is progressing; Kandra and MiKayla Kent will attend training virtually during the week of March 14; and a request for a bean bag toss tournament for the Community Building. A suggestion was made to refer the request to the Golf Course.
- c. Attorney Report Lisa Shifflet reported that she must publish for 30 days a public notice regarding the abandoned car.

### Unfinished Business:

- a. Twin Valleys Public Power District proposed contract Mayor Gunderson reported on contract details – capital improvements will be billed at actual cost; commencement date will be April 1. Dave Houghtelling will get drawings from Olsson and submit to Twin Valleys.
- b. Employee Handbook update City Attorney will prepare a resolution to approve the Employee Handbook for the next meeting.

### New Business:

a. Special Designated Liquor Permit – Cambridge Golf Club – Fish Fry & Pitch Tournament Vernita Saylor stated the motion, seconded by Tony Groshong, to approve the Special Designated Liquor Permit for the Cambridge Golf Club to host a fish fry and pitch tournament on March 19, 2001 at the Cambridge Community Building. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf. Mike Harris abstained from voting, none voted no. Motion carried unanimously by Council members voting.

Citizen Comments – Jessica Fischer was present for Tri Valley Health System. She gave an update on the thefts at the Thrift Store – bins have been installed for drop-off, working with law enforcement and more cameras will be installed. Jessica thanked City Council for the use of the Community Building for Covid vaccinations. Additionally, Jessica reported that staff is working on the "C" wing of the Heritage Plaza.

### **Reports of Officers, Board and Committees:**

Melissa Jackson, Director of Economic Development, reported on a recent Strategic Planning Session. A subject discussed was to have a community poll to determine the best business for the area. Economic Development is looking at a Micro TIF and the eligibility of a grant from USDA for emergency equipment.
