REPORTS OF OFFICERS, BOARDS AND COMMITTEES:

- a. <u>Economic Development Director Report</u> Melissa Jackson advised Council of the following items: Internship grant for the Library; Down payment Assistance (3); Façade grants (2); a new housing rehab grant program was approved; three new houses will be under construction in Harvest Meadows this Spring. Melissa reported there will be three vacancies on the Citizen Advisory Board and replacements will be needed.
- b. <u>Chamber of Commerce Co-Chairman Report</u> Melissa Jackson requested \$1800 assistance for funding Medicine Creek Days fireworks. Jeff Ommert stated the motion, seconded by Tony Groshong, to approve the City funding \$1,800 for Medicine Creek Days fireworks. Voting yes were Tony Groshong, Jeff Ommert, Mike Harris and Kevin Banzhaf; absent and not voting were

Vernita Saylor and Derek Raburn; none voted no. Motion carried unanimously by City Council Members present.

- c. <u>Ambulance/Fire Reports</u> John Kutnink reported there were 14 runs in February. He also advised that power load cot training for EMTs was held last week. The upgrade will be delivered and installed.
- d. <u>Utility Supervisor Report</u> Dave Houghtelling reported on the following: a new generator cost for the upgrade will total \$226,885 as a result of the switchgear being separate from the generator. Kevin Banzhaf stated the motion, seconded by Jeff Ommert, to approve the additional cost of \$28,200 to the generator project. Voting yes were Tony Groshong, Jeff Ommert, Mike Harris and Kevin Banzhaf; absent and not voting were Vernita Saylor and Derek Raburn; none voted no. Motion carried unanimously by City Council Members present. Dave further reported that the sewer camera project is behind schedule due to the cold weather; flow at the sewer plant was restricted last week; the sewer jetter pump needs repairs; and that Dave and Mike Tomlin attended training in Kearney on backflow.
- e. <u>City Clerk/Treasurer Report</u> Kandra Kinne advised that the audit is nearly complete and the report will be ready at the next meeting. She also reported that a nuisance letter was sent to a citizen, and the Notice of Taxable Status from Furnas County Assessor was received.
- f. <u>Hospital Report</u> Jessica Fisher advised that Tri Valley Health System has free Covid Rapid Test Kits available for the public.

NEW BUSINESS:

A .Kylie Koeppen – Permit to keep laying hens at 915 Niobrara Street - Kylie Koeppen has submitted a Permit Application to Keep Fowl and attached the permission form from neighboring residents. Tony Groshong stated the motion, seconded by Mike Harris, to approve the Permit Application to Keep Fowl of Kylie Koeppen. Voting yes were Tony Groshong, Jeff Ommert, Mike Harris and Kevin Banzhaf; absent and not voting were Vernita Saylor and Derek Raburn; none voted no. Motion carried unanimously by City Council Members present.

b. Ordinance No. 799 – An Ordinance amending the Cambridge, Nebraska Zoning Ordinance and Subdivision Regulations Reports of 2015, Revised August 2020; Amending Article 2, Section 2-503 Conditional Uses adding Automotive and Truck Sales; to repeal other conflicting ordinances and sections and direct the publication or this ordinance and to provide an effective date – First Reading. Jeff Ommert stated the motion, seconded by Tony Groshong, to approve Ordinance No. 799 on first reading Amending Article 2, Section 2-503 Conditional Uses adding Automotive and Truck Sales. Mayor Gunderson read the Ordinance by title. Voting yes were Tony Groshong, Jeff Ommert, Mike Harris and Kevin Banzhaf; absent and not voting were Vernita Saylor and Derek Raburn; none voted no. Motion carried unanimously by City Council Members present for the first reading of Ordinance No. 799.

- C. <u>Ho Jo's Special Designated Liquor Permit April 9, 2022</u> Kevin Banzhaf stated the motion, seconded by Mike Harris, to approve the Special Designated Liquor Permit of Ho Jo's Hideaway for an event on April 9, 2022. Voting yes were Tony Groshong, Jeff Ommert, Mike Harris and Kevin Banzhaf; absent and not voting were Vernita Saylor and Derek Raburn; none voted no. Motion carried unanimously by City Council Members present.
- d. <u>Cross Creek Golf Links Special Designated Liquor Permit April 1, 2022</u> Tony Groshong stated the motion, seconded by Jeff Ommert, to approve the Special Designated Liquor Permit of Cross Creek Golf Links for an event on April 1, 2022. Voting yes were Tony Groshong, Jeff Ommert, Mike Harris and Kevin Banzhaf; absent and not voting were Vernita Saylor and Derek Raburn; none voted no. Motion carried unanimously by City Council Members present.
