Pursuant to notice published in the Valley Voice on Thursday, April 1, 2021, the Cambridge City Council convened in open public meeting at 6:30 P.M. on April 5, 2021 at the Cambridge Community Building. Present were Mayor David Gunderson, City Council Members Vernita Saylor, Mike Harris, Derek Raburn, Tony Groshong, Jeff Ommert and Kevin Banzhaf. City Staff present were Utility Supervisor David Houghtelling, City Clerk/Treasurer Kandra Kinne; City Attorney Lisa Shifflet, Economic Development Director Melissa Jackson and Head Librarian Maria Downer. Visitors present were Genny Kubik for *The Valley Voice*; Terry Engel for *Hometown Agency*, Jessica Fischer, CEO of *Tri Valley Health System*, and present by Zoom was Schuyler Sharp, CPA at *Contryman Associates*. Mayor Gunderson opened the meeting with the Pledge of Allegiance. Mayor Gunderson announced the open meeting law is posted on the east wall of the meeting room and available for public inspection.

New Business:

Schuyler Sharp of Contryman Associates gave the results of the recent Audit Report. He advised that all records look good with no changes. The income statement was discussed. \$380,000 of which was mostly from grants and donations related to Downtown Revitalization. Expenses included \$400,000 related to grant projects. Other topics discussed included LB840 donations, bonds, expenses related to debt payment, operating expenses, etc. Sharp advised that the fund balance is in good shape, but suggested monitoring the water fund loss. Vernita Saylor stated the motion, seconded by Jeff Ommert, to accept the Audit Report. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Mike Harris, Derek Raburn and Kevin Banzhaf. None voted no. Motion carried unanimously to approve the Audit Report.

Consent Agenda: Minutes of March 15, 2021 and the claims report. The City Council received a copy of the minutes of March 15, 2021 and the claims report prior to this meeting and a final claims report at this meeting. Derek Raburn stated the motion, seconded by Mike Harris, to approve the minutes of March 15, 2021 and the claims report. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Mike Harris, Derek Raburn and Kevin Banzhaf. Jeff Ommert abstained from voting on Ommert Tech. None voted no. Reports of Officers, Boards and Committees:

Economic Development - Director Melissa Jackson reported on the status of building at Harvest Meadows and discussed with Council a new business.

Library Report – Maria Downer reported on the situation of asbestos in the ceiling of the old part of the library building and potential roof leaks. After discussion, it was concluded that she will contact Miller & Associates on advice for the asbestos and an adjuster to review the roof situation.

Park Board Report – The minutes of the March 18 meeting had one correction - that the name of the disc golf course will be McKinley Park Disc Golf. Baseball is considering having someone condition the fields before games. A pickle ball court is being planned for the park.

Utility Supervisor – Dave Houghtelling reported on the following projects: a handrail for the ramp at Sunny Hillside Schoolhouse, repairing curb stands, generation, pool reopen in May and repairs on a pole.

City Clerk/Treasurer – Kandra Kinne reported on the following: payroll conversion, Nebraska Tax Advantage and American Rescue Act funds.

Tri Valley Health System – Jessica Fischer reported on the projects at Heritage Plaza: reviewing grant for new dining hall windows and construction updates. She thanked Council for the use of the Community Building for vaccinations. She also reported that the bin at the Thrift Store had to be replaced due to vandalism.

New Business:

Hometown Agency – EMC Dividend – Terry Engel of Hometown Agency reported on the dividend from EMC in the amount of \$27,105.69 which represented 21 percent of the last annual premium.

Reports of Officers, Boards and Committees:

City Attorney – Lisa Shifflet reported on the process of Land Banks, new legislation to assist with dilapidated properties. Smaller communities need area communication to form the Land Bank starting with building the inventory. Other steps would then follow but clear title would be much easier than the existing system. Lisa explained funding, communities' pledges and financing. She will provide further information to Council.

New Business:

Ommert Technologies Computer Agreement – Council members discussed the proposed Information Technology Leasing Agreement with Jeff Ommert. Vernita Saylor stated the motion, seconded by Kevin Banzhaf, to continue the current agreement with Ommert Technologies. Voting yes were Vernita Saylor, Tony Groshong, Mike Harris, Derek Raburn and Kevin Banzhaf. None voted no. Jeff Ommert abstained. Motion carried unanimously by those Council members voting.

Rodeo Area Equipment – roping chute – Discussion was held regarding selling the roping chute which is no longer in use at the arena. Tony Groshong stated the motion, seconded by Vernita Saylor, to sell the roping chute and use the funds for the arena. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Mike Harris, Derek Raburn and Kevin Banzhaf. None voted no. Motion carried unanimously.

Mayor and City Council Comments: It was noted that the basement at 504 Patterson Street has not been filled. Truck parking on the old highway is less, but also the old highway is not located in the City limits.

Convene CDA:

a. Convene CDA & adjourn City Council - Vernita Saylor stated the motion, seconded by Derek Raburn, to adjourn City Council and convene for the Community Development Agency. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Mike Harris, Derek Raburn and Kevin Banzhaf. None voted no. Motion carried unanimously to adjourn City Council at 8:03 P.M. and convene the CDA.

COMMUNITY DEVELOPMENT AGENCY OF THE CITY OF CAMBRIDGE, NEBRASKA RESOLUTION # 2021-04-01

(Redevelopment Plan Amendment - Harvest Meadows Fourth Project – Lot 5, Block 1)

A RESOLUTION OF THE COMMUNITY DEVELOPMENT AGENCY OF THE CITY OF CAMBRIDGE, NEBRASKA, APPROVING AND ADOPTING A SUPPLEMENTAL AMENDMENT TO THE REDEVELOPMENT PLAN OF THE CITY OF CAMBRIDGE, NEBRASKA, TO IMPLEMENT A SPECIFIC PHASE OF THE HARVEST MEADOWS FOURTH REDEVELOPMENT PROJECT IN THE REDEVELOPMENT AREA; ADOPTING A COST BENEFIT ANALYSIS FOR SAID PHASE OF THE REDEVELOPMENT PROJECT; AND TAKING OTHER ACTIONS REQUIRED OR PERMITTED UNDER THE COMMUNITY DEVELOPMENT LAW.

RECITALS

- A. The City of Cambridge, Nebraska ("City"), has adopted a general redevelopment plan ("Redevelopment Plan") for certain portions of the City of Cambridge, Nebraska as defined in the Redevelopment Plan (the "Redevelopment Area").
- B. The Redevelopment Plan includes a specific residential subdivision redevelopment project known as the Harvest Meadows Fourth Project (the "Subdivision Project"). The Subdivision Project was adopted and designed to be implemented and constructed in multiple phases.
- C. The Community Development Agency of the City of Cambridge, Nebraska ("CDA"), in furtherance of the purposes and pursuant to the provisions of the Community Development Law, <u>Neb. Rev. Stat.</u> §§ 18-2101 to 18-2154, as amended (the "Act") has prepared the Amendment to the Redevelopment Plan attached hereto as <u>Exhibit "A"</u> and incorporated by this reference (the "Amendment").
- D. The Amendment would create a specific phase of the Subdivision Project (the specific phase shall be referred to as the "Project").
- E. The Subdivision Project has been previously approved by the CDA pursuant to the Act, and the Project is the implementation of one phase of the approved Subdivision Project.
- F. The Amendment supplements the Redevelopment Plan amendment for the Subdivision Project to identify one phase of the Subdivision Project, and the Amendment will not constitute a substantial modification to the Redevelopment Plan.
- G. The Project would use tax increment financing pursuant to Section 18-2147 of the Act to assist in paying for the cost of public utility improvements including, but not limited to, construction and extension of public utility improvements, public infrastructure improvements, and other eligible public improvements authorized by the Act, including repayment of indebtedness incurred by the City to construct the eligible public improvements for the Subdivision Project.
- H. The CDA is required under Section 18-2113(2) of the Act to conduct a cost-benefit analysis for any project which shall use tax increment financing.
- I. The CDA has previously conducted and approved a cost-benefit analysis for the Subdivision Project, but desires to supplement said cost-benefit analysis to specifically analyze the phase of the Subdivision Project constituting this Project.
- J. The CDA has conducted and drafted a cost-benefit analysis for the Project, and said cost-benefit analysis is attached to the Amendment as <u>Exhibit "C"</u> thereto (the "Cost-Benefit Analysis").
- K. The CDA has previously determined that the Subdivision Project would not occur in the Redevelopment Area and could not be financed or constructed but for the use of Tax Increment Financing.
- L. The Subdivision Project would not have been approved by the CDA without the anticipated and expected subsequent phases, including this Project.

NOW THEREFORE, BE IT RESOLVED by the Community Development Agency of the City of Cambridge, Nebraska, as follows:

- 1. The Amendment will, in accordance with the present and future needs of the City of Cambridge, promote the health, safety, morals, order, convenience, prosperity, and the general welfare of the community in conformance with the legislative declarations and determinations set forth in the Act.
- 2. The Amendment is in conformance with the general plan for development of the City of Cambridge as a whole, as set forth in the City of Cambridge Comprehensive Plan, as amended.

- 3. The costs and benefits of the Project (as the current phase of the Subdivision Project) have been found to be in the best interest of the City Cambridge.
 - 4. The Project Site is within the Redevelopment Area.
- 5. The Project implements one phase of the Subdivision Project in conformance with the Redevelopment Plan.
- 6. The Subdivision Project would not be economically feasible and would not occur in the Redevelopment Area without the use of Tax Increment Financing on the Project (the current phase of the Subdivision Project).
- BE IT FURTHER RESOLVED, pursuant to the provisions of the Act and in light of the foregoing findings and determinations, the CDA hereby approves and adopts the Cost-Benefit Analysis as the cost-benefit analysis for the Project.
- BE IT FURTHER RESOLVED, pursuant to the provisions of the Act and in light of the foregoing findings and determinations, the CDA hereby adopts the Amendment and amends the Redevelopment Plan as set forth therein.

BE IT FURTHER RESOLVED, the CDA hereby rescinds any other resolutions or actions that are contradictory or incompatible with this Resolution.

c. Resolution 2021-04-02 Redevelopment Plan Contract – Harvest Meadows Fourth Project Lot 5, Block 1. Jeff Ommert stated the motion, seconded by Vernita Saylor, to approve Resolution 2021-04-02 Redevelopment Contract – Harvest Meadows Fourth Project Lot 5, Block 1. (Redevelopment Contract – Harvest Meadows Fourth Project – Lot 5, Block 1)

A RESOLUTION OF THE COMMUNITY DEVELOPMENT AGENCY OF THE CITY OF CAMBRIDGE, NEBRASKA, AUTHORIZING AND APPROVING A REDEVELOPMENT CONTRACT FOR A REDEVELOPMENT PROJECT UTILIZING TAX INCREMENT FINANCING; AND TAKING OTHER ACTIONS REQUIRED OR PERMITTED UNDER THE COMMUNITY DEVELOPMENT LAW.

RECITALS

- A. The City of Cambridge, Nebraska ("City"), has adopted a general redevelopment plan ("Redevelopment Plan") for certain portions of the City of Cambridge, Nebraska as defined in the Redevelopment Plan (the "Redevelopment Area").
- B. The Community Development Agency of the City of Cambridge, Nebraska ("CDA"), in furtherance of the purposes and pursuant to the provisions of the Community Development Law, Neb. Rev. Stat. §§ 18-2101 to 18-2154, as amended (the "Act") has approved the Amendment to the Redevelopment Plan (the "Amendment") to create and implement the Harvest Meadows Fourth Project Lot 5, Block 1 ("Project") as one phase of the Harvest Meadows Fourth Project in the Redevelopment Area.
- C. The CDA has prepared a redevelopment contract for the Project, a copy of which is attached hereto as <u>Exhibit "A"</u> and incorporated by this reference (the "Redevelopment Contract").
- D. The Project would use tax increment financing pursuant to Section 18-2147 of the Act to assist in paying for the cost of certain eligible public improvements authorized by the Act and identified in the Redevelopment Plan and the Redevelopment Contract.

NOW THEREFORE BE IT RESOLVED, the CDA hereby approves the Redevelopment Contract and authorizes the Chairperson of the CDA to execute and enter into the Redevelopment Contract, with such changes, modifications, additions, and deletions that are necessary or appropriate, for and on behalf of the CDA.

BE IT FURTHER RESOLVED, the CDA hereby authorizes the Chairperson of the CDA to take all actions contemplated and required in the Redevelopment Contract including, without limitation, the issuance of TIF Indebtedness as set forth in the Redevelopment Contract. Such TIF Indebtedness shall be repaid solely from the Tax Increment created by the Project and does not represent the general obligation of the CDA or the City.

BE IT FURTHER RESOLVED, the CDA hereby rescinds any other resolutions or actions that are contradictory or incompatible with this Resolution.

BE IT FURTHER RESOLVED, the foregoing resolutions are subject to and contingent upon the City Council's approval and adoption of the Amendment, and if the City Council does not approve and adopt the Amendment, the resolutions contained herein shall be void and of no effect.

d. Adjourn CDA - Tony Groshong stated the motion, seconded by Mike Harris, to adjourn CDA at 8:08 P.M. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Mike Harris, Derek Raburn and Kevin Banzhaf. None voted no. Motion carried unanimously.
