REPORTS OF OFFICERS, BOARDS AND COMMITTEES:

- a. <u>Economic Development Report</u> Melissa Jackson, Director, reported on the following: Intern grant applications were approved; two Down Payment Assistance loans were approved; and the Economic Development Board approved donating \$500 to Amateur's for the fire-fighting appreciation dinner.
- b. <u>Fire/Ambulance Report</u> Delaine Soucie, Fire Chief, reported on the Fire Department's grass rig situation. The four rigs are 1995, 1995, 2008 and 2021 and the 1995s need replaced. One rig is overheating. Soucie recommended replacing one grass with a 4500 or 5500 Dodge and the fire department putting together the skid unit for the truck. He estimated the cost at about \$100,000. He also recommended building new skid units to go on a new truck. A rotation plan for trucks was suggested and also having trucks checked for repairs for overheating. Jeff Ommert stated the motion, seconded by Vernita Saylor, to approve the purchase of a grass rig contingent upon the Rural Fire Board approving payment of one-half the cost. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf; absent and not voting was Mike Harris; none voted no. Motion carried unanimously by City Council Members present.
- c. <u>Planning Commission</u> Vernita Saylor stated the motion, seconded by Tony Groshong, to deny the Site Plan and Land Use Application of Kyle Broadfoot at 616 Shole Avenue for a garage and lean to as the application does not meet the zoning requirements. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf; absent and not voting was Mike Harris; none voted no. Motion carried unanimously by City Council Members present to deny the application of Kyle Broadfoot. Vernita Saylor stated the motion, seconded by Tony Groshong, to approve the Site Plan and Land Use Applications of Tara Gross at 1016 Neosha

Street for a fence, and Logan Baker at 824 Flannery Avenue for a fence. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf; absent and not voting was Mike Harris; none voted no. Motion carried unanimously by City Council Members present to approve the applications of Tara Gross and Logan Baker.

D <u>Library Report</u> – The asbestos has been removed and the condition of the ceiling is being assessed.

- e. <u>Museum Report</u> Advertising has commenced for a curator to replace Betty Kruger, who recently retired.
- f. Utility Supervisor Report Dave Houghtelling reported on the following: he has marked streets for armor coating; and has 11 proposals with a low bid of \$74,494.05. Tony Groshong stated the motion, seconded by Vernita Saylor, to accept the proposal from Figgins Construction for \$74,494.05 for armor coating and authorizes the Mayor to sign the proposal. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf; absent and not voting was Mike Harris; none voted no. Motion carried unanimously by City Council Members present. Dave also recommended that Council declare the 2016 line truck as surplus. Vernita Saylor stated the motion, seconded by Derek Raburn, to declare the 2016 line truck as surplus. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf; absent and not voting was Mike Harris; none voted no. Motion carried by unanimously by City Council Members present. Dave reported that he has ordered repairs for manholes.
- b. <u>City Clerk/Treasurer Report</u> Kandra Kinne reported on the following: The Financial Report for March was included in Council packets. She also advised the need for a Resolution for when a customer becomes a "cash only" customer. The City Council received annual Report on Community Development Projects.
