Unfinished Business:

Ambulance Bid – Larry Maatsch and John Kutnink, Cambridge EMTs, addressed Council and reviewed the bid for a new ambulance. Discussion was held regarding additional equipment needs for radios and cots. Vernita Saylor stated the motion, seconded by Tony Groshong, to accept the proposal from American Response Vehicles for a 2022 AEV Traumahawk Type III Custom 172" x 96" x 72" Ford E450, 7.3L Gasoline Ambulance for \$222,730.00 as stated in the July 15, 2021 proposal. Delivery will be 240 to 300 days after confirmation. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn, Mike Harris and Kevin Banzhaf. Motion carried unanimously.

Reports of Officers, Boards and Committees:

- **a.** Planning Commission Report Vernita Saylor stated the motion, seconded by Jeff Ommert, to approve the following Site Plan and Land Use Permit Applications: Phil Schlagel at 510 Parker Street for a fence; and the City of Cambridge at 115 Nelson Street for swimming pool renovation. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn, Mike Harris and Kevin Banzhaf.
- **b. Utility Supervisor Report** Dave Houghtelling reported on the following: Figgins Construction has completed street work; a water line break on Nevada Street; controls repaired at the water tower; contractor here tomorrow to look at pool and schedule start date; the pool will close August 1; and a new water valve was installed on Parker Street.

- **c. Clerk/Treasurer Report** Kandra Kinne reported on the following: received first half of ARPA NEU payment of \$88,670.86; financial report complete for June 30, 2021; meter reading was delayed as the belt clip failed. Tony Groshing stated the motion, seconded by Vernita Saylor, to purchase another belt clip for backup for meter reading. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn, Mike Harris and Kevin Banzhaf. Motion carried unanimously.
- **d. City Attorney Report** Lisa Shifflet reported on the details of the initial organizational meeting of the Southwest Nebraska Land Bank meeting recently held in McCook. By-Laws will need to be written and inter-local agreements prepared. The Board for the Land Bank will be comprised of one voting member from each community. Kevin Banzhaf volunteered to represent the City of Cambridge.
- **e. Hospital Report** Jessica Fisher reported on the following: Thrift Store thefts are decreasing; motion lights are installed at the Thrift Store; Heritage Plaza is doing well; hospital newsletter due soon; and staff is staying current on the COVID Delta Variant.

Unfinished Business:

Net Metering – City Attorney Lisa Shifflet reported on net metering. She is preparing a policy similar to that of Twin Valleys Public Power District, but will need a rate schedule.

New Business:

- **a. Employee Health Insurance Renewal** Steve Johnson of Northwestern was present for health insurance questions. Insurance premiums increased 8.48 percent. Jeff Ommert stated the motion, seconded by Vernita Saylor, to approve the increase with the employee to pay 20 percent of the premium. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn, Mike Harris and Kevin Banzhaf. Motion carried unanimously.
- **b. HoJo's Hideaway Special Designated Liquor Permit for August 28, 2021** Vernita Saylor stated the motion, seconded by Tony Groshong, to approve the Special Designated Liquor Permit for HoJo's Hideaway for August 28, 2021. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn, Mike Harris and Kevin Banzhaf. Motion carried unanimously.
- c. Casey's General Store, Manager License Tyra Bailey, local manager for Casey's General Store, was present for questions. She advised that Krystal Carter should be designated as Manager for all Casey's stores in Nebraska. Vernita Saylor stated the motion, seconded by Derek Raburn, to have Krystal Carter designated as the manager for liquor licensing purposes for Casey's General Store in Cambridge. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn, Mike Harris and Kevin Banzhaf. Motion carried unanimously.

- **d. Jake & Carmon Swisher Lease Agreement** Derek Raburn stated the motion, seconded by Mike Harris, to approve the Lease Agreement between the City of Cambridge and Jake & Carmon Swisher for Lot 2, Harvest Meadows 5th for a period of one year at \$150 per month. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn, Mike Harris and Kevin Banzhaf. Motion carried unanimously.
- **e. Golf Course Sign Lease** The proposed Sign Lease Agreement between the City of Cambridge and Cross Creek Golf Links lacks a termination clause. The golf board will review at its next meeting. Jeff Ommert stated the motion, seconded by Derek Raburn, to approve the Sign Lease Agreement between the City of Cambridge and Cross Creek Golf Links with the addition of a termination clause for a term of five years at \$1. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf. Mike Harris abstained from voting. Motion carried.

Unfinished Business:

- a. Brad Williams discussion to request Modification to Cambridge Zoning Regulation 12-102 Brad Williams will meet with City Attorney Lisa Shifflet who is researching other municipalities in this situation.
- **b. Mayor and City Council Comments** Mayor Gunderson advised that he had discussion with the State of Nebraska about using the south water well for de-watering which is located in the flood plain.

c. Public Comments - None
