Communications/Appointments:

Museum Board – Tony Groshong stated the motion, seconded by Derek Raburn to approve the reappointment of Larry Cornett to the Museum Board for a five-year term, July 2025. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf, none voted no. Motion carried unanimously.

Introduction of Ordinance:

Ordinance No. 773 – to change the Zoning Class of South 100 feet of Lot 7, Block C, Pickle and Cameron Addition and the North 100 feet of the South 200 feet of Lot 7, Block C, Pickle and Cameron Addition. Mayor Gunderson gave the second reading of Ordinance No. 773. Vernita Saylor stated the motion, seconded by Jeff Ommert, to approve the second reading of Ordinance No. 773 changing the Zoning Class of the South 100 feet of Lot 7, Block C, Pickle and Cameron Addition and the North 100 feet of the

South 200 feet of Lot 7, Block C, Pickle and Cameron Addition. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf, none voted no. Motion carried unanimously for Ordinance No. 773 as follows:

Ordinance No. 773

AN ORDINANCE CHANGING THE ZONING CLASSIFICATION OF SOUTH 100 FEET OF LOT 7, BLOCK C, PICKLE AND CAMERON ADDITION, AND THE NORTH 100 FEET OF SOUTH 200 FEET OF LOT 7, BLOCK C, PICKLE AND CAMERON ADDITION, CITY OF CAMBRIDGE, FURNAS COUNTY, NEBRASKA FROM RESIDENTIAL ZONING CLASSIFICATION TO COMMERICAL ZONING CLASSIFICATION; PROVIDING FOR PUBLICATION AND EFFECTIVE DATE.

Ordinance No. 774 – to amend Chapter 3, Section 303, to establish a limit on the number of fowls. Derek Raburn stated the motion seconded by Kevin Banzhaf, to waive the three readings of Ordinance No. 774. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf, none voted no. Motion carried unanimously. Vernita Saylor stated the motion, seconded by Tony Groshong to amend Chapter 3, Section 303, to limit the number of fowls to six. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf, none voted no. Motion carried unanimously for Ordinance No. 774 as follows:

Ordinance No. 774

AN ORDINANCE OF THE CITY OF CAMBRIDGE, NEBRASKA, TO ENACT CHAPTER 3, SECTION 303 OF THE CITY OF CAMBRIDGE MUNICIPAL CODE TO ESTABLISH LIMITED NUMBER OF FOWLS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMBRIDGE, NEBRASKA:

Section 1. That Chapter 3, Section 303 of the City of Cambridge Municipal Code is hereby added and enacted to read as follows:

3-303 FOWLS; WRITTEN PERMISSION, LIMIT NUMBER. It shall be unlawful for any person to keep on his or her private property poultry, chickens, turkeys, geese, or other fowls unless and until they have received the written consents of the owners or lessees of the properties immediately adjoining the private property, as well as all other property owners within 150 feet of the place where such animals are to be kept, and to keep no more than six poultry, chickens, turkeys, geese or other fowls, and no Roosters, which consents shall be filed at the office of the city clerk and shall be subject to revocation by any of the said owners or lessees at any time. In the event any of the consents are revoked, the person keeping poultry, chickens, turkeys, geese, or other fowls or animals shall have 30 days to remove the same after being notified by the city clerk that such consents have been revoked. Said person shall also apply to the city clerk for a permit from the City Council which shall also be subject to revocation at any time.

Section 2. Any other Ordinance or Section passed and approved prior to this ordinance that is in conflict with this Ordinance is hereby repealed.

Section 3. This Ordinance shall be in full force and effect from and after its final passage and publication as required by law.

Reports of officers, board and committees:

Miller and Associates Reports: Luke Dutcher and Mason Herrman of Miller & Associates appeared via zoom to discuss the following:

DTR Project Downtown – Street lighting and inlets for storm drains at the Nevada Street intersection. Luke will update estimates to include Nelson Street.

Community Development Block Grant Program (Program Income Repurposing) – Mason introduced two contracts for the program (1) Construction Management Services, and (2) Technical and Professional Services Contract. Tony Groshong stated the motion, seconded by Jeff Ommert, to approve the Construction Management Services Contract for Community Development Block Grant Program and the Technical and Professional Services Contract for Community Development Block Grant Program. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf, none voted no. Motion carried unanimously.

Economic Development Program – The City did not receive sales tax this month.

Ambulance/Fire Report – Kim Shifflet was presented to discuss a quote from River Valley Service for HVAC improvements to the Fire Barn. He also advised that one pumper truck needs transmission repair which is cost prohibitive and recommends replacement which could cost \$60,000.00. He expressed concern for mutual aid as other communities are not providing as much equipment and manpower as in the past. He recommended having an inventory of trucks to determine if any could be taken out of service. Vernita Saylor stated the motion, seconded by Tony Groshong, to approve the HVAC updates to the Fire Barn in the amount of \$6,422.75 to River Valley Service. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf, none voted no. Motion carried unanimously.

Planning Commission – Derek Raburn stated the motion, seconded by Tony Groshong, to approve the following Site Plan and Land Use Permit Applications: Steve & Eileen Johnson, 914 Furnas Avenue, for a concrete patio with fire pit; Miguel Arambula, 1012 Park Avenue, to replace chain link fence with six-foot privacy fence; Kent Davis, 710 Nasby Street, to install two fence panels; Eisenhart & Farquhar, 301 Nelson Street, to remove and install sidewalks, driveways, and flat surfaces and to install two new windows and a front door; and City of Cambridge, 115 Nelson Street, handicap ramp and sidewalk at Sunny Hillside Schoolhouse Museum. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf, none voted no. Motion carried unanimously.

Sunny Hillside Schoolhouse Museum – The floor is done, furniture moved from storage unit to schoolhouse, windows washed and books cleaned.

Fairview/St. John's Cemetery Report - Common Scents sprayed for bag worms on July 12.

Library Report – Minutes of the July 8 meeting were received.

City Clerk/Treasurer Report – Kandra advised that she has published liquor license renewals for Amateurs, Corner Café, Cambridge Golf, Cambridge Lanes and Town Talk Restaurant; the line loss report was 3.17% for electric and 17.67% for water; Virginia provided a review of area cemetery fees since our fees have not been raised since the early 1980's; Virginia is working on a list of abandoned cemetery spaces; Kandra is working on applications with FEMA and Nebraska Cares Act for costs incurred for COVID; Kandra recommended initiating utility disconnects and offer payment plans; there is interest in

the property purchased for the fire barn; and she has received compliments on our park and on the community.

Utility Supervisor Report – Dave advised that he has contacted a contractor to trim trees in power lines. The contractor can begin work at the end of August. Council suggested putting a flyer in the next utility bills advising the public of tree trimming. Vernita Saylor stated the motion, seconded by Tony Groshong to approve hiring Double L to trim trees in the power lines for \$44,000.00. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf, none voted no. Motion carried unanimously. Dave advised the Work Ethic Camp will be here this week for Cemetery trimming.

New Business:

Lease Agreement with Jake & Carmon Swisher – Tony Groshong stated the motion, seconded by Vernita Saylor, to approve the Lease Agreement with Jake & Carmon Swisher to lease Lot 2, Harvest Meadows Fifth, for a one-year term. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf, none voted no. Motion carried unanimously.

Resolution to Set Fees – Council had been provided a copy of proposed fees to review. Jeff Ommert stated the motion, seconded by Vernita Saylor to approve Resolution No. 2020-07-01 establishing fees and charges for the City of Cambridge. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf, none voted no. Motion carried unanimously for Resolution 2020-07-01 as follows:
