Pursuant to notice published in the Valley Voice on August 17, 2023, the Cambridge City Council convened in open public meeting at 6:30 P.M. on August 21, 2023 at the Cambridge Community Building, 722 Patterson Street. Present were Mayor David Gunderson, City Council Members Vernita Saylor, John Kutnink, Jeff Ommert, Nora McGowen and Kevin Banzhaf. City Council Member Mike Harris was absent. City Staff present were City Clerk/Treasurer Courtney Stanton, Utility Supervisor Dave Houghtelling, Utility Billing Clerk Bethany Stritt and City Attorney Lisa Shifflet. Visitors present were David Blau *Miller and Associates*, Steve Johnson, Dennis Wahlmeier, Jessica Fisher *Tri Valley Health System*, Amber Anderson *The Olson Group via Zoom* and Taylor Provost *West Central Nebraska Development District via Zoom*. Mayor Gunderson opened the meeting with the Pledge of Allegiance. Mayor Gunderson announced the open meeting law is posted on the east wall of the meeting room and available for public inspection.

Dave Houghtelling suggested adding alleys. Millings and armor coating is considered maintenance and are not required to be included in the plan. City Clerk/Treasurer Report – Courtney Stanton reported sales tax received and distribution and included Furnas County Sheriff's report.

New Business:

Steve Johnson and Amber Anderson were present to discuss proposed City LIGHT Plan. LIGHT is made up of a pool of municipalities across Nebraska who participate in the plan. Cambridge City employees have already filled out health application for under writing. The only differences between the BCBS renewal plan and the City LIGHT Plan BCBS is the Common Family Deductible and Employee (plus spouse, employee and children) versus age banded. The city will save approximately \$3,169 per month on premiums and family deductible with be \$6,000.00 instead of \$9,600 with the renewal plan. The city will continue to pay half of the employee deductible and 80% of the employee's premium. John Kutnink stated the motion, seconded by Vernita Saylor, to approve City LIGHT Plan BCBS H.S.A.
