# City of Cambridge Regular City Council Meeting Monday, September 08, 2020 6:40 P.M.

Notice of meeting was given in advance by publication in the *Cambridge Clarion*, Thursday, August 27, 2020, the designated method of giving notice, convening at 6:40 P.M. Advance notice of the meeting was given to the Mayor, Members of the City Council, and the *Cambridge Clarion*. Present were Mayor David Gunderson, City Council Members Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf. City Staff present were Utility Supervisor David Houghtelling, City Clerk/Treasurer Kandra Kinne and City Attorney Lisa Shifflet. Visitors present for all or a portion of the meeting were Genny Kubik for the *Cambridge Clarion*, Mike Harris and Terry Galloway. Mayor Gunderson announced the open meeting law poster is posted on the east wall of the meeting room and available for public inspection. A RESOLUTION OF THE COMMUNITY DEVELOPMENT AGENCY OF THE CITY OF CAMBRIDGE, NEBRASKA, APPROVING AND ADOPTING A SUPPLEMENTAL AMENDMENT TO THE REDEVELOPMENT

PLAN OF THE CITY OF CAMBRIDGE, NEBRASKA, TO IMPLEMENT A SPECIFIC REDEVELOPMENT PROJECT IN THE REDEVELOPMENT AREA; ADOPTING A COST BENEFIT ANALYSIS FOR SAID REDEVELOPMENT PROJECT; AND TAKING OTHER ACTIONS REQUIRED OR PERMITTED UNDER THE COMMUNITY DEVELOPMENT LAW.

#### **RECITALS**

- A. The City of Cambridge, Nebraska ("City"), has adopted a general redevelopment plan ("Redevelopment Plan") for certain portions of the City of Cambridge, Nebraska as defined in the Redevelopment Plan (the "Redevelopment Area").
- B. The Community Development Agency of the City of Cambridge, Nebraska ("CDA"), in furtherance of the purposes and pursuant to the provisions of the Community Development Law, <u>Neb. Rev. Stat.</u> §§ 18-2101 to 18-2154, as amended (the "Act") has prepared the Amendment to the Redevelopment Plan attached hereto as <u>Exhibit "A"</u> and incorporated by this reference (the "Amendment").
- C. The Amendment will create a specific redevelopment project on a portion of the Redevelopment Area and Harvest Meadows more properly described in the Amendment ("Project").
- D. The Amendment will not constitute a substantial modification to the Redevelopment Plan.
- E. The Project would use tax increment financing pursuant to Section 18-2147 of the Act to assist in paying for the cost of public utility improvements including, but not limited to, construction and extension of public utility improvements, public infrastructure improvements, and other eligible public improvements authorized by the Act, including repayment of indebtedness incurred by the City to construct the eligible public improvements for the Project.
- F. The CDA is required under Section 18-2113(2) of the Act to conduct a cost-benefit analysis for any project which shall use tax increment financing.
- G. The CDA has conducted and drafted a cost-benefit analysis for the Project, and said cost-benefit analysis is attached to the Amendment as <u>Exhibit "C"</u> thereto (the "Cost-Benefit Analysis").

NOW THEREFORE, BE IT RESOLVED by the Community Development Agency of the City of Cambridge, Nebraska, as follows:

- 1. The Amendment will, in accordance with the present and future needs of the City of Cambridge, promote the health, safety, morals, order, convenience, prosperity, and the general welfare of the community in conformance with the legislative declarations and determinations set forth in the Act.
- 2. The Amendment is in conformance with the general plan for development of the City of Cambridge as a whole, as set forth in the City of Cambridge Comprehensive Plan, as amended.
- 3. The costs and benefits of the Project have been found to be in the best interest of the City Cambridge as required by Neb. Rev. Stat. § 18-2113 of the Act.
  - 4. The Project Site is within the Redevelopment Area.
- 5. The Project would not be economically feasible and would not occur in the Redevelopment Area without the use of Tax Increment Financing on the Project.

BE IT FURTHER RESOLVED, pursuant to the provisions of the Act and in light of the foregoing findings and determinations, the CDA hereby approves and adopts the Cost-Benefit Analysis as the cost-benefit analysis for the Project.

BE IT FURTHER RESOLVED, pursuant to the provisions of the Act and in light of the foregoing findings and determinations, the CDA hereby adopts the Amendment and amends the Redevelopment Plan as set forth therein.

BE IT FURTHER RESOLVED, the CDA hereby rescinds any other resolutions or actions that are contradictory or incompatible with this Resolution.

C. Motion to Approve Redevelopment Contract Resolution 2020-09-02 Harvest Meadows Third Project, Lot 3, Block 3. Derek Raburn stated the motion, seconded by Jeff Ommert, to approve the Redevelopment Contract Resolution 2020-09-02 Harvest Meadows Third Project, Lot 3, Block 3. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn, Kevin Banzhaf and Mike Harris, none voted no. Motion carried unanimously for Resolution 2020-09-02 as follows:

A RESOLUTION OF THE COMMUNITY DEVELOPMENT AGENCY OF THE CITY OF CAMBRIDGE, NEBRASKA, AUTHORIZING AND APPROVING A REDEVELOPMENT CONTRACT FOR A REDEVELOPMENT PROJECT UTILIZING TAX INCREMENT FINANCING; AND TAKING OTHER ACTIONS REQUIRED OR PERMITTED UNDER THE COMMUNITY DEVELOPMENT LAW.

#### **RECITALS**

- A. The City of Cambridge, Nebraska ("City"), has adopted a general redevelopment plan ("Redevelopment Plan") for certain portions of the City of Cambridge, Nebraska as defined in the Redevelopment Plan (the "Redevelopment Area").
- B. The Community Development Agency of the City of Cambridge, Nebraska ("CDA"), in furtherance of the purposes and pursuant to the provisions of the Community Development Law, Neb. Rev. Stat. §§ 18-2101 to 18-2154, as amended (the "Act") has approved the Amendment to the Redevelopment Plan (the "Amendment") to create and implement the Harvest Meadows Third Project Lot 1, Block 3 ("Project") as one phase of the redevelopment of Harvest Meadows in the Redevelopment Area.
- C. The CDA has prepared a redevelopment contract for the Project, a copy of which is attached hereto as <a href="Exhibit"><u>Exhibit "A"</u></a> and incorporated by this reference (the "Redevelopment Contract").
- D. The Project would use tax increment financing pursuant to Section 18-2147 of the Act to assist in paying for the cost of certain eligible public improvements authorized by the Act and identified in the Redevelopment Plan and the Redevelopment Contract.

NOW THEREFORE BE IT RESOLVED, the CDA hereby approves the Redevelopment Contract and authorizes the Chairperson of the CDA to execute and enter into the Redevelopment Contract, with such changes, modifications, additions, and deletions that are necessary or appropriate, for and on behalf of the CDA.

BE IT FURTHER RESOLVED, the CDA hereby authorizes the Chairperson of the CDA to take all actions contemplated and required in the Redevelopment Contract including, without limitation, the issuance of TIF Indebtedness as set forth in the Redevelopment Contract. Such TIF Indebtedness shall be repaid solely from the Tax Increment created by the Project and does not represent the general obligation of the CDA or the City.

BE IT FURTHER RESOLVED, the CDA hereby rescinds any other resolutions or actions that are contradictory or incompatible with this Resolution.

BE IT FURTHER RESOLVED, the foregoing resolutions are subject to and contingent upon the City Council's approval and adoption of the Amendment, and if the City Council does not approve and adopt the Amendment, the resolutions contained herein shall be void and of no effect.

E. Adjourn CDA and Reconvene City Council Meeting. Derek Raburn stated the motion, seconded by Tony Groshong, to adjourn CDA and Reconvene City Council Meeting. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn, Kevin Banzhaf and Mike Harris, none voted no. Motion carried unanimously. Reconvene City Council Meeting at 6:55 p.m.

# **Reports of Officers, Boards and Committees:**

Miller & Associates – Swimming Pool Project: Discussion was held on the bid opening held on September 2 including possible deducts and the Inter-local Agreement with the Village of Wilsonville.

Minutes – Council has received the Minutes of the August 19, 2020 Library Board meeting and the reports on progress in Fairview Cemetery, McKinley Park and the Sunny Hillside Schoolhouse Museum.

Utility Supervisor Report – Dave Houghtelling advised of the following: the heater at the pool is winterized, all the pool is winterized and the splash pad will be winterized. The contractor performing trees trimming in the power lines started work last week. After the tragedy at the City of McCook, the differences in the wastewater systems was discussed.

City Clerk/Treasurer Report – Kandra Kinne advised of the following: the 1-6 year street plan will be on the next agenda; EMS has applied for a grant for one-half the cost of the monitor; working with FEMA for COVID Response costs; Planning Commission will have a public hearing for a conditional use permit for Alan Koerperich on September 23; Salary Ordinance for 2020-2021 budget year at the next meeting; and there was one utility disconnect for non-payment which will need a lien filing.

# **Unfinished Business:**

Employee Handbook – Discussion was held regarding the confusion of the PTO section, and holiday pay.

# **New Business:**

a. Terry Galloway – Harvest Meadows home request for assistance. Mr. Galloway addressed Council and requested assistance in the amount of \$16,000.00 explaining his justification for this request. The City was paid the value of the lien in the Trustee sale. Terry said usually the person receives the lot free with a contract to build a home and the lien is forgiven after the contract is satisfied. Terry asked to the funds as incentive to complete the house since the city received the funds in the Trustee Sale. He was advised of the City's status in this property and the TIF contract, because the TIF contract is in default and was given one extension to complete the house. Jeff Ommert stated the motion, seconded by Tony Groshong, to deny Mr. Galloway's request for assistance. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn, Kevin Banzhaf and Mike Harris, none voted no. Motion carried unanimously to deny Terry Galloway's request for assistance.

b. Verena (Rena) Farr to EMT Roster. Tony Groshong stated the motion, seconded by Jeff Ommert, to approve that Verena (Rena) Farr be added to the EMT roster. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn, Kevin Banzhaf and Mike Harris, none voted no. Motion carried unanimously to add Verena (Rena) Farr to the EMT roster for the City of Cambridge.

c.Dow Newcomb request for an additional lot in Harvest Meadows. The Joint Committee comprised of City Council members and Economic Development members has met regarding Mr. Newcomb's request and determined that the request had to be made at the time of purchase.

d.Harvest Meadows. City Council members discussed extending Prairie View Drive and also Wheat Ridge Drive. The City Council asked for estimates for the construction.
