- 1. Hearing to set the final tax request at a different amount than the prior year City Clerk/Treasurer Kandra Kinne reported that the public hearing is to set the final tax request which will be \$271,582 with a levy of .508629. There was no public comment.

- 2. Approve Increase in Restricted Funds Authority Derek Raburn stated the motion, seconded by Vernita Saylor, to approve the increase in Restricted Funds Authority by 1%. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn, Mike Harris and Kevin Banzhaf. Motion carried unanimously.
- 3. Approve Resolution Number 2021-09-01 to set the Final Tax Request Jeff Ommert stated the motion, seconded by Derek Raburn, to approve Resolution #2021-09-01 setting the Final Tax Request. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn, Mike Harris and Kevin Banzhaf. Motion carried unanimously for Resolution 2021-09-01 as follows:

RESOLUTION NO. 2021-09-01 (Resolution to set property tax Levy)

WHEREAS, Nebraska Revised Statute 77-1601.02 provides that the Governing Body of the City of Cambridge passes by a majority vote a resolution or ordinance setting the tax request; and

WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request; and

WHEREAS, it is in the best interests of the City of Cambridge that the property tax request for the current year be a different amount than the property tax request for the prior year.

NOW, THEREFORE, the Governing Body of the City of Cambridge, by a majority vote; resolves that;

1. The 2021-2022 property tax request be set at:

General Fund \$271,582.00 Public Safety Bond \$16,895.00

- 2. The total assess value of property differs from last year's total assessed value by 16.05 percent.
- 3. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property would be 0.431518 per \$100 of assessed value.
- 4. The City of Cambridge proposes to adopt a property tax request that will cause its tax rate to be .508629 per \$100 of assessed value.
- 5. Based on the proposed property tax request and changes in other revenue, the total operating budget of the City of Cambridge will increase last year's budget by 16.27 percent.
- 6. A copy of this resolution be certified and forwarded to the County Clerk on or before October 13, 2021.

Derek Raburn stated the motion, seconded by Jeff Ommert, to approve Ordinance Number 789 to adopt the Budget. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn, Mike Harris and Kevin Banzhaf. Motion carried unanimously.

Ordinance No. 789

AN ORDINANCE TO ADOPT THE BUDGET STATEMENT TO BE TERMED THE ANNUAL APPRORIATION BILL; TO APPROPRIATE SUMS FOR NECESSARY EXPENSES AND LIABILITIES; TO PROVIDE FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF CAMBRIDGE, NEBRASKA:

Section 1. That after complying with all procedures required by law, the budget presented and set forth in the budget statement is hereby approved as the annual appropriation bill for the fiscal year beginning October 1, 2021 through September 30, 2022. All sums of money contained in the budget statement are hereby appropriated for the necessary expenses and liabilities of the City of Cambridge. A copy of the budget document shall be forwarded as provided by law to the Auditor of Public Accounts, State Capitol, Lincoln, Nebraska, and to the County Clerk of Furnas County, Nebraska, for the use by the levying authority.

Section 2. This Ordinance shall take effect and be in full force from and after its passage, approval, and publication as required by law.

Resolution to adopt the Quad Counties Multi-Jurisdictional Hazard Mitigation Plan Update in its entirety

WHEREAS, the Federal Disaster Mitigation Act of 2000 was signed in to law on October 30, 2000, placing new emphasis on state and local mitigation planning for natural hazards and requiring communities to adopt a hazard mitigation action plan to be eligible for pre-disaster and post-disaster federal funding for mitigation purposes; and

WHEREAS, a Multi-Jurisdictional Hazard Mitigation Plan was prepared by Franklin, Furnas, Harlan, and Red Willow Counties, with assistance from JEO Consulting Group, Inc.

WHEREAS, the purpose of the mitigation plan was to lessen the effects of disasters by increasing the disaster resistance of the counties and participating jurisdictions located within the planning boundary by identifying the hazards that affect the City of Cambridge and prioritize mitigation strategies to reduce potential loss of life and property damage from those hazards, and

WHEREAS, FEMA regulations require documentation that the plan has been formally adopted by the governing body of the City of Cambridge, Nebraska in the form of a resolution and further requesting approval of the plan at the Federal Level; and

NOW, THEREFORE, the governing body of the City of Cambridge does hereby adopt the Quad Counties Multi-Jurisdictional Hazard Mitigation Plan Update in its entirety; and
