# City of Cambridge Regular City Council Meeting Monday, September 21, 2020 6:30 P.M.

Notice of meeting was given in advance by publication in the *Valley Voice*, Thursday, September 17, 2020, the designated method of giving notice, convening at 6:30 P.M. Advance notice of the meeting was given to the Mayor, Members of the City Council, and the *Valley Voice*. Present were Mayor David Gunderson, City Council Members Vernita Saylor, Tony Groshong, Jeff Ommert, and Kevin Banzhaf. Councilman Mike Harris was absent. City Staff present were Utility Supervisor David Houghtelling, City Clerk/Treasurer Kandra Kinne, City Attorney Lisa Shifflet and Pool Director Sara Calvert. Visitors present for all or a portion of the meeting were Larry Steele of Miller & Associates and Genny Kubik for the *Valley Voice*. Mayor Gunderson announced the open meeting law poster is posted on the east wall of the meeting room and available for public inspection. Mayor Gunderson opened the meeting with the Pledge of Allegiance.

**Public Hearing: 1-6 Year Street Plan:** Mayor Gunderson opened the Public Hearing. Larry Steele of Miller & Associates presented information on the one-year plan for highway lighting, and passing lane on Highway 6/34, street improvements, and on the six-year plan for drainage ditch. Highway allocation was \$154,629.08 this year. The City provides a 25 percent match.

Councilman Derek Raburn entered the meeting.

The street project for Harvest Meadows was discussed – Prairie View Drive, Harvest Drive and an amendment to the culvert project. Council asked Steele to look at FEMA for Flood Plain Mitigation.

There was no public comment. Mayor Gunderson closed the Public Hearing at 6:48 p.m.

Vernita Saylor stated the motion, seconded by Tony Groshong to pass Resolution No. 2020-09-04 adopting the 1-6 Year Street Plan which is amended to add Harvest Meadows Street plan and eliminate #37. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Derek Raburn and Kevin Banzhaf, none voted no, and Mike Harris was absent and not voting. Vernita Saylor stated the motion, seconded by Tony Groshong, to approve the following site plan and land use permit applications: Andrew Sickels of 902 Furnas Avenue for garage and fence; Jake & Breanna Witte of 1021 Nevada Avenue to remove/replace front porch and columns and remove/replace concrete steps with wooden steps; Gloria Rodriguez of 912 Park Avenue to install vinyl siding; Johnathan & Kimberly Fegley of 514 Penn Street to install six-foot wood privacy fence and asphalt shingles; Hector Garcia of 921 Pacific Street for a room addition; Cambridge Memorial Hospital dba Tri Valley Health System of 1205 West Highway 6/34 to replace plate glass windows, frame in a garage door, remove/replace existing sidewalk; and Alan Koerperich of 40203 Corn Husk Lane to construct a single family residence. **City Clerk/Treasurer Report** – Kandra Kinne advised of the following: budget letters have been submitted to customers; Sheriff contract automatically renewed each year with three percent increase; October 1 starts the new fiscal year; Planning Commission will have public hearing on September 23<sup>rd</sup> for a conditional use permit; working with Dave Custer of Twin Valleys PPD for an electrical service agreement after Clint Wickizer retires; and the sales tax records have been received. Kandra also provided a report on the comments and funds received from the RV Park.
