## Reports of Officers, Boards and Committees:

Park Board – Minutes of December 17, 2020 meeting included in Council packets. The Park Board recommended a monetary contribution to Sara Downey for her dedication of time spent in the flower gardens. Vernita Saylor stated the motion, seconded by Tony Groshong, to pay \$100 to Sara Downey. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Mike Harris, Derek Raburn and Kevin Banzhaf, none voted no. Motion carried unanimously by City Council members present to pay \$100 to Sara Downey.

Utility Supervisor – Dave Houghtelling reported on the following: a house that John Fegley purchased was moved through town today; Cummins gave a three-year estimate of \$8,982 for three generators, sewer plant and two lift stations which includes oil changes, batteries, belts and other maintenance – breakdown work is an additional cost; and the grader is in North Platte for maintenance.

City Clerk/Treasurer – Kandra Kinne reported on the following: the workmen's compensation experience rating for 2021-22 has dropped to .84; received check from trustee's sale of the Harvest Meadows lot; LB922 changes utility disconnect language; the 2021 Voluntary Contribution Notice for Nebraska Unemployment Insurance; financial reports for October and November 2020; formal request information; and line loss.

Vernita Saylor stated the motion, seconded by Mike Harris to approve submitting the Site Plan and Land Use Permit application of Jake Swisher for a business sign at 42503 Wheat Ridge Drive to the Planning Commission. Voting yes were Vernita Saylor, Tony Groshong, Jeff Ommert, Mike Harris, Derek Raburn and Kevin Banzhaf, none voted no. Motion carried unanimously to submit the Site Plan and Land Use Permit for Jake Swisher for a business sign at 42503 Wheat Ridge Drive to the Planning Commission.

Approve to Advertise for Summer Help (Park, Cemetery, and Swimming Pool) – Discussion was held on a Recreation Director position and the number of employees for summer mowing. It was decided to advertise for three positions for maintenance at the park, cemetery and general as well as for Recreation Director, lifeguards, pool manager and assistant pool manager.

Mayor and City Council Comments – Kevin Banzhaf asked about the Paul Dow Newcomb request for a split of the neighboring lot. The Joint Committee is waiting for an answer from the builder who has submitted a request to purchase the lot.
