Mayor Gunderson removed claim #40 from consent agenda.

John Kutnink stated the motion, seconded by Vernita Saylor to approve items listed under the consent agenda. Voting yes were Vernita Saylor, John Kutnink, Jeff Ommert, Nora McGowen and Kevin Banzhaf; absent and not voting was Mike Harris; none voted no. Motion carried unanimously.

Vernita Saylor stated the motion, seconded by John Kutnink to approve claim #40. Voting yes were Vernita Saylor, John Kutnink, Nora McGowen and Kevin Banzhaf; abstaining from vote was Jeff Ommert; absent and not voting was Mike Harris; none voted no. Motion carried unanimously. Mayor David Gunderson reported that Miller & Associates sent letters to Utility entities regarding easements and the preliminary plat for the Harvest Meadows 10th project. Miller & Associates stated bids would need to be acquired. Public hearings would be held, preliminary plat would go to Planning Commission and then to City Council for approval. Mayor Gunderson stated that Miller & Associates would be present at the City Council meeting on December 18 to discuss upcoming projects.

David Houghtelling reported a level two assessment which is good now and water samples went out on Monday. Nebraska Department of Environment and Energy inspected the tree and grass pile and said everything is fine. Dave will be meeting on December 14th with Nebraska Public Power District, Nebraska Corn Processing and Twin Valleys Public Power District to discuss generation. Dave spoke with Miller &

Associates regarding sewer plant repairs to rotors, electrical, screw pumps and digester. Chris Miller with get estimates for sewer plant repairs and upgrades. The city is working on replacing street signs. Faw Motor Co. got a pickup in the city could purchase, the cost is \$43,000 with trade and no box, cost of the box would be an additional \$10,000 to \$12,000. Dave discussed the possibility of waiting on a mower and purchasing the box for budget reasons. Vernita Saylor stated the motion, seconded by John Kutnink, to approve purchase of the 2024 ¾ ton Chevrolet in the amount of \$43,000. Voting yes were Vernita Saylor, John Kutnink, Jeff Ommert, Nora McGowen and Kevin Banzhaf; absent and not voting was Mike Harris; none voted no. Motion carried unanimously.

Courtney Stanton reported auditors came for a preliminary visit to become familiar with the City of Cambridge. Courtney has heard nothing from Utility Financial Solutions regarding electric rate study. She will reach out again.

Amanda Huxoll and Chris Haveman were not in attendance and will not be able to attend a December City Council meeting.

Melissa Jackson, Ashley Gerlach and Tom Shoemaker presented information regarding the Rural Workforce Housing Grant, Cambridge Housing Study Lite, Summary of Workforce Housing and support letters. Rural Workforce Housing Grant is for any type of housing and had no income restrictions. Grant could be awarded in the amount of up to \$2.5 million. Cambridge Daycare foundations is applying for the grant as the 501C3. There are private donors. Cambridge Economic Development made motion to repurpose the revolving loan budget line item of \$162,000 to the capital projects-workforce housing line item. In order to apply for the grant a Housing Study Lite was completed. Ashley Gerlach stated in 2022 the Nebraska Department of Economic Development dispersed the first round of Workforce Housing Grant funds. The time line for this round of funds would be received in the second quarter 2024.

Vernita Saylor stated the motion, seconded by John Kutnink, to approve Resolution No. 2023-12-01

Resolution 2023-12-01

Signing of the Year-End Certification of City Street Superintendent 2023 **Whereas:** State of Nebraska Statutes, sections 39-2302, and 39-2511 through 39-2515 details the requirements that must be met in order for a municipality to qualify for an annual incentive payment; and

Whereas: The State of Nebraska Department of Transportation (NDOT) requires that each incorporated municipality must annually certify (by December 31st of each year) the appointment of the City Street Superintendent(s) to the NDOT using the Year-End Certification of City Street Superintendent form; and Whereas: The NDOT requires that each certification shall also include a copy of the documentation of the City street superintendent's appointment, i.e., meeting minutes; showing the appointment of the City Street Superintendent by their name as it appears on their License (if applicable), their License Number (if applicable), and Class of License (if applicable), and type of appointment, i.e., employed, contract (consultant, or inter-local agreement with another incorporated municipality and/or county), and the beginning date of the appointment; and

Whereas: The NDOT also requires that such Year-End Certification of City Street Superintendent form shall be signed by the Mayor or Village Board Chairperson and shall include a copy of a resolution of the governing body authorizing the signing of the Year-End Certification of City Street Superintendent form by the Mayor or Village Board Chairperson.

Be it resolved that the Mayor of the City of Cambridge is hereby authorized to sign the attached Year-End Certification of City Street Superintendent completed form(s).

Nora McGowen stated the motion, seconded by Jeff Ommert, to appoint Christopher Miller #S-1091A of Miller & Associates, Consulting Engineers, P.C., as Street Superintendent. Voting yes were Vernita Saylor, John Kutnink, Jeff Ommert, Nora McGowen and Kevin Banzhaf; absent and not voting was Mike Harris; none voted no. Motion carried unanimously.

Vernita Saylor stated the motion, seconded by John Kutnink, to appoint Christopher Miller of Miller & Associates, Consulting Engineers, P.C., as City Engineer.
