- a. Miller & Associates, Inc.
  - (1) Downtown Revitalization Project. For consideration are the following drawdowns for submission to CBDG: #13 \$2,500.00; #14 \$44,910.29 and #15 \$13,883.87 and the application for payment from Blessing Construction for \$120,265.20. Keith Luedders stated the motion, seconded by Jeff Ommert, to approve the three drawdowns and the application for payment. Voting yes were Tony Groshong, Jeff Ommert, Vernita Saylor, Keith Luedders and Kevin Banzhaf, none voted no, and Derek Raburn was absent and not voting. Motion carried unanimously by City Council members present for Drawdowns #13 \$2,500.00, #14 \$44,910.29 and #15 \$13,883.87 to be submitted to CDBG and the application for payment to Blessing Construction for \$120,265.20.
  - (2) Swimming Pool Project Contract

Larry Steele of Miller & Associates, Inc. presented the contract to design the improvements for the swimming pool project which will have a budget of \$1,270,000.00. Vernita Saylor stated the motion, seconded by Tony Groshong, to approve the contract with Miller & Associates. Voting yes were Tony Groshong, Jeff Ommert, Vernita Saylor, Keith Luedders and Kevin Banzhaf, none voted no, and Derek Raburn was absent and not voting. Motion carried unanimously by City Council members present to approve the contract with Miller & Associates.

Motion carried unanimously by City Council Members present. Mayor Gunderson stated the only item discussed in executive session was the position of Economic Development Director and that no decision was made in executive session.

Motion carried unanimously by City Council members present.

  - 3. Update City Limits Map Discussion was held on updating the city limits map and to review potential annexation.

Kandra has received the Library Board minutes for December. The house at 510 Butler is being removed.
