Reports of Officers, Boards and Committees:

<u>Miller and Associates Report</u>: The downtown businesses have scheduled a meeting for Thursday June 20, 2019 to discuss the upcoming downtown revitalization project. The meeting will be held at the community building.

<u>Economic Development Report</u>: Economic Development Director, Monica Lueking, reported boosted Facebook ads daily for various businesses, attend City Council, Chamber of Commerce, Rotary and Chamber of Commerce Board meetings and gave Economic Development updates, met with residents regarding down payment assistance programs, met with businesses regarding façade grants, had inquiries about Harvest Meadow lots, promoted local businesses with business of the month ads, worked with Fire Spring to update the business maps, forwarded the map to H2O in Arapahoe for a metal map to display in the kiosk in the park, and attended leadership small group meetings to work on the volunteer fair. <u>Planning Commission Report</u>: The City Council received a copy of the Planning Commission Report prior to this meeting. Derek Raburn stated the motion, seconded by Jeff Ommert, to approve the Planning Commission report. On roll call vote Vernita Saylor, Tony Groshong, Jeff Ommert, Keith Luedders and Derek Raburn voted yes, none voted no and Tom McCarville was absent and not voting. Motion carried unanimously by City Council Members present for the following site plan and land use permit applications: Sierra Guthrie, 1010 Nelson Street, for a Fence.

<u>City Clerk/Treasurer Report:</u> City Clerk/Treasurer, Kandra Kinne, provided copies of correspondence from the Nebraska Department of Revenue that the LB840 Sales Tax has been certified to extend until 2035, received valuations changes for City property for the 2019 year, received notice from the Nebraska Department of Revenue about a Nebraska Advantage Act sales and use tax refund, Pinpoint annual shareholder meeting was held June 12, LB840 Sales Tax receipt report for June 2019, Financial reports for March 2019 and April 2019.

City Council discussed using LB840 dollars toward the horse arena project and the downtown revitalization lighting project.

<u>Sheriff Contract</u>: The City Council received a copy of the proposed Sheriff Contract for July 1, 2019 to June 30, 2020. Keith Luedders stated the motion, seconded by Jeff Ommert, to approve the Furnas County Inter-local Law Enforcement Cooperation Agreement between the City of Cambridge and Furnas County. On roll call vote Vernita Saylor, Tony Groshong, Jeff Ommert, Keith Luedders and Derek Raburn voted yes, none voted no and Tom McCarville was absent and not voting. Motion carried unanimously by City Council Members present.

<u>Cemetery Property and Personnel.</u> The City Council discussed Fairview Cemetery is probably owned by the Fairview Cemetery Foundation and costs associated with the operation of the Fairview Cemetery should be funded by the Fairview Cemetery Foundation instead of the tax levy from the City.

<u>Agreement, negotiations, and survey – Heritage Plaza:</u> The City Council reviewed information about the survey of the Heritage Plaza. The City Council decided to proceed with a variance for the east garage, for a portion of the building that is located on City property, abandon a portion of the street right of way for a portion of the east wing that is located on street right-of-way, and dedicate the portion of land to the Tri Valley Assisted Living that is located on City property. The City Council table action until the final survey of the Heritage Plaza could be received.

City Council discussed a request to move utility easement from the location between lots Seven and Eight, Block Two, Fourth addition, to the north side of Lot Six, Block Two, Fourth Addition. The City Council asked for more information about utilities that may be located on the property.

<u>Nuisance Abatement:</u> The City Council received the written report from the Nuisance Abatement Officer of West Central Nebraska Development District. Tony Groshong stated the motion, seconded by Jeff Ommert to approve Resolution 2019-06-08 Rescinding Prior Resolution No. 2017-06-06 Declaration of Nuisance Property. On roll call vote Vernita Saylor, Tony Groshong, Jeff Ommert, Keith Luedders and Derek Raburn voted yes, none voted no and Tom McCarville was absent and not voting. Motion carried unanimously by City Council Members present for Resolution 2019-06-08 as follows:
